### Overview

In accordance with the **Stop Campus Hazing Act, California Anti-Hazing Law**, and **CHSU's Anti Hazing Act Policy**, this report provides a summary of all substantiated hazing incidents involving students or student organizations that were investigated and adjudicated through formal College proceedings. This report is intended to promote transparency, accountability, and student safety and is updated annually.

For each substantiated hazing incident below is the following information:

- The name of the student or student organization;
- The date the investigation was initiated;
- The date on which the investigation ended with a finding that a violation occurred;
- A description of the incident or incidents, including the date of the initial violation, and the violations, findings, and sanctions placed on the student or student organization;
- The details of the sanction or sanctions imposed, including the beginning and end dates of the sanction or sanctions; and
- The date that the student or student organization was charged with a violation.
