

Job Title**Part-Time Behavioral Health Specialist, College of Medicine****Job Description:**

The Behavioral Health Specialist has the responsibility of providing behavioral health services in a one-on-one setting with CHSU students. This specialist provides encouragement and support to help with the overall wellness of CHSU medical students. Key components of the position include assessing students' needs, identifying and addressing student challenges, providing individual counseling, assisting students with the development of goals and action plan, and providing community resources and referrals as necessary.

Reports to:**Director of Student Services****Classification:****Part Time, Non - Exempt****Essential Duties:**

- Provide assessment and intervention of psychosocial/behavioral health issues for CHSU students. Guide students in the development of skills and strategies to cope with personal challenges.
- Provide crisis intervention during the hours of 3:00pm to 7:00pm, Monday to Friday Act as an advocate to coordinate services or resolve emergency problems in crisis situations.
- Build rapport and inspire confidence to attract students who may be in need-of counseling services.
- Consult with Behavioral Health Specialist and Office of Student Affairs regarding students' mental health as needed.
- Work collaboratively with CHSU Administration, Faculty, and Educational Skills
- Provide crisis intervention during student mental health emergencies.
- Appropriately refer students to community resources and services as needed.
- Actively participate in professional development to effectively provide evidence-based strategies on mental and behavioral health issues.
- Implement counseling and educational methods and strategies (i.e. breathing techniques, journaling, fatigue mitigation, etc.)
- Perform other duties as assigned or directed to meet the goals and objectives of the organization.
- Maintain accurate and confidential student records in counseling services.

- Master's degree in Mental Health Counseling, Marriage and Family Therapy, Clinical Psychology, Licensed Clinical Social Worker, or related field. Candidates with a degree in Clinical/ Counseling Psychology must come from an APA accredited program.
