- Provide oversight for the department, including hiring performance reviews and recommendations for promotion of all faculty of the department.
- Plan for, develop and deliver curricular components of the Clinical Presentation TBL patient discussions.
- Assure faculty develop appropriate learning objectives for each session and learning activity delivered.
- Direct the creation of pre-classroom assignments, such as narrated PowerPoints, case based materials and other readings.
- Assure test questions and assessment tool correspond with the learning objectives.
- Participate in Item Writing Workshops to develop test writing skills.
- Participate in quality improvement of the clinical education programs to assure their effectiveness.
- Participate in COM committees such as Admissions, Awards, Curriculum, etc.
- Serve as an advisor for a cohort of medical students of all specialties.
- · Serve as a Faculty advisor for student groups/clubs.
