

Job Title:**Osteopathic Principles and Practices Faculty, College of Osteopathic Medicine****Job Description:**

The Osteopathic Principles and Practices (OPP) faculty in the College of Osteopathic Medicine (COM) assures osteopathic philosophy, osteopathic principles, and the osteopathic tenets are taught broadly throughout the curriculum. The primary responsibilities involve teaching osteopathic medical students the tenets, principles, and practices of osteopathic medicine. This occurs primarily within the OPP courses of the 1st and 2nd years, as well the development of an integrated osteopathic curriculum for delivery in the 3rd and 4th years.

Essential Duties:

- **Teaching:** Deliver instruction in 1st and 2nd year medical student curriculum and teach through the continuum of osteopathic medical education. Additional time dedicated to 3rd and 4th year required elements. Work collaboratively with other faculty members to deliver and improve the integrated and interdisciplinary osteopathic medical curriculum in all 4 years. Work collaboratively with OPP student scholars to help grow a cadre of osteopathic scholars.
- **Service:** Provide service (committee responsibilities, student mentoring, interviewing, etc.).
- **Scholarship:** Time devoted to scholarly activity and optional clinical activity:
 - Participate in educational and other possible research activities.
 - Provide supervision of medical students and their scholarly projects.
- Other duties as assigned.

In the execution of job duties, faculty member must abide by all CHSU and COM policies, procedures, and syllabi requirements. This job description is not intended to be all inclusive and the faculty member will also perform other reasonably related duties as assigned by the Department Chair.
