SIMULATION ADVISORY COUNCIL POLICY

PURPOSE

The purpose of the CHSU Simulation Center and Program Advisory Council is to represent the community at large, champion simulation-based learning, and counsel effective integration of simulation-based learning activities into the applicable CHSU student curriculum.

SCOPE

This policy affects all users (internal and external) of the Simulation Center including Simulation Center personnel.

POLICY STATEMENT

The Simulation Center and Program operates with a Simulation Advisory Council comprised in general of membership that represents all genders and reflects the ethnic diversity of the community served, or at a minimum, represents the diversity of healthcare.

The Council provides guidance in shaping the course of interprofessional simulation healthcare education, operating procedures, and future planning to the CHSU Simulation staff and faculty.

Membership is by invitation from the Simulation Center Director in collaboration with the CHSU President, Provost, CHSU Dean of the College of Osteopathic Medicine, Associate Dean for Osteopathic Clinical Education and Simulation, and CHSU faculty. Recommendations from current council members are encouraged.

Members have a three-year term limit unless member requests to step down. Any member can be invited to remain on the council at the end of their term.
